FRANCIS CENTRE AND/OR THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, REPRESENTATIVES, AND AGENTS, INCLUDING THE FAILURE ON THE PART OF MEDJUGORJE CENTRE OF CANADA, ST. FRANCIS CENTRE, AND/OR THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, REPRESENTATIVES, AND AGENTS, TO SAFEGUARD OR PROTECT ME FROM RISKS, DANGERS AND HAZARDS WHILE ON THE RETREAT. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage and loss resulting therefrom.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of Medjugorje Centre of Canada accepting my application and permitting my presence from the time and date of the first day of the retreat _____ (date) to the time and date of the last day of the retreat _____ (date) (hereinafter referred to as "The Retreat") I hereby agree as follows:

- 1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against Medjugorje Centre of Canada, St. Francis Centre, and their directors, officers, employees, agents, representatives, successors and assigns (all of whom are hereinafter collectively referred to as the "The Releases") and to release the Releasees from any and all liability of any loss, damage, expense, or injury including death that I may suffer, or that my next of kin may suffer as a result of my presence on The Retreat due to any cause whatsoever; INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE ON THE PART OF THE RELEASES, AND INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS ON THE RETREAT AS REFERRED TO ABOVE;
- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my presence on The Retreat;
- 3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
- 4. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of Ontario;

In entering into this Agreement I am not relying on any oral or written representatives or statement made by the Releasees other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
